NOTICE OF DEFEASANCE

of Certain Outstanding

Arizona Transportation Board

Notice is hereby given, on behalf of the Arizona Transportation Board (the "Board"), that the outstanding bond identified on Schedule I hereto (the "Refunded Bond") has on October 6, 2016 been defeased and refunded in advance of its stated maturity date, by the establishment of an irrevocable trust account with The Bank of New York Mellon Trust Company, N.A., Dallas, Texas, as Escrow Trustee. The moneys and maturing principal and interest on certain obligations issued or guaranteed by the United States government which have been deposited in such trust account are scheduled to provide funds in amounts sufficient, as shown in the written verification report of Grant Thornton LLP, for the timely payment, when due, of principal of, redemption premium, if any, and interest on such Refunded Bond to its redemption date shown on Schedule I.

The Refunded Bond maturing on the date listed on Schedule I will be called for optional redemption on the redemption date listed on Schedule I, by payment of the price thereof listed on Schedule I, plus accrued interest.

This notice of defeasance does not constitute the notice of the redemption of the Refunded Bond. The notice of redemption will be subsequently mailed by us, U.S. Bank National Association, as the Paying Agent for the Refunded Bond, to the registered owner of the Refunded Bond.

The Board has represented that, in accordance with the provisions of the applicable resolution of the Board pursuant to which the Refunded Bond was authorized and issued, as a result of this deposit in such trust account the payment of the Refunded Bond has been provided for and the Refunded Bond is no longer outstanding under its authorizing resolution.
