## **Puerto Rico Electric Power Authority**

### **Additional / Voluntary Event-Based Disclosure**

The Puerto Rico Electric Power Authority (“PREPA”) hereby gives notice to all holders of the Power Revenue Bonds, Series YY (Issuer Subsidy Build America Bonds) (the “Series YY Bonds”) as follows:

By letter dated February 14, 2019, the Internal Revenue Service (the “IRS”) notified PREPA that it is examining a Form 8038-CP related to the Series YY Bonds. PREPA intends to respond to all correspondence from the IRS and intends to continue to cooperate with the IRS in connection with the examinations.

PREPA has not undertaken to provide any further information regarding these examinations except to the extent that it may be obligated to give notice of any future adverse tax opinions or other events affecting the tax-exempt status of the Series YY Bonds in accordance with the applicable continuing disclosure agreement.
