NOTICE OF POTENTIAL REFINANCING

Effective February 1, 2019, Dignity Health, a California nonprofit public benefit corporation and Catholic Health Initiatives, a Colorado nonprofit corporation (collectively, the "Historical Organizations") have aligned their respective ministries as a single, Catholic, nonprofit health system known as CommonSpirit Health (collectively, the "System"). As part of the alignment, it is intended that the indebtedness and obligations of the respective Historical Organizations will be consolidated into a single credit.

The System is currently evaluating restructuring and/or refinancing indebtedness including all or a portion of the bonds listed on the attached Exhibit A (collectively, the "Prior Bonds") in calendar year 2019. Any refinancing of the Prior Bonds may be financed through the issuance of one or more new series of taxable and tax-exempt bonds (collectively, the "Bonds"), System funds or other sources of capital and may depend on the market and other conditions. The System anticipates that Citigroup Global Markets Inc., J.P. Morgan Securities LLC and Morgan Stanley & Co. LLC will serve as senior managing underwriters in connection with the issuance of any Bonds. There is no assurance that all or any portion of the Prior Bonds will be refinanced or that the consolidation into a single credit will be completed and if any such Prior Bonds are refinanced or consolidation into a single credit is completed, the timing thereof.

This Notice is not made by the System in connection with a purchase or sale of the Bonds, and accordingly is not intended to contain all information material to a decision to purchase or sell the Bonds. This Notice does not constitute a notice of redemption or defeasance for the Prior Bonds. In the event any Prior Bonds are to be refinanced, those notices will be provided as contemplated by the related bond indentures for such Prior Bonds.
