



## Xavier University, OH Bond Rating Withdrawn Upon Issuer's Request

SAN FRANCISCO (S&P Global Ratings) May 8, 2020--S&P Global Ratings said today that it has withdrawn its 'A-' long-term rating on the outstanding bonds of Xavier University, Ohio, at the issuer's request. The rating outlook was negative at the time of the withdrawal.
